Subject: Storage and Safety arrangement of EVMs – Regarding.


Sir,

I am directed to state that in partial modification to Commission's instruction No. 51/8/6/2010-EMS dated 3rd May, 2010, on the subject cited, and to state that in order to provide an inlet/outlet for air-circulation to avoid foul smell in the strong rooms, the Commission has decided to allow installation of one exhaust fan in the strong-rooms used for storage of the EVMs, subject to the condition that suitable safeguards for the safety of the EVM are taken up at the time of installation of exhaust fan, viz.

1. A strong iron grill shall be installed at the vent/passage where exhaust fan will be installed.
2. Exhaust Fan shall be installed on the front side of the strong-room, where security guard are posted and not on the rear side.
3. Exhaust Fan shall be installed at the highest point feasible, below the roof.
