I am directed to forward herewith Proceedings, dated 13th January, 2014 (along with its Hindi version) of the Election Commission of India regarding issue of Notification by the President under Section 12 of the Representation of the People Act, 1951, calling upon the elected members of the Legislative Assembly of 16 States to elect 55 members to fill the seats in the Council of States that will become vacant due to retirement/resignation/death of sitting members whose term of office is due to expire in the Month of April, 2014.

PROCEEDINGS

WHEREAS, the seats of 55 members of the Council of States, elected by the elected members of the Legislative Assemblies of the States, specified in column (1) of the TABLE below, as per the numbers shown in the corresponding entries in column (2) of the Table, are due to fall vacant on the retirement of those members, on the dates mentioned in the corresponding entries in column (3) of the TABLE, on the expiration of their term of office; and

WHEREAS, biennial elections have to be held for the purpose of filling the above vacancies so arising;

NOW, THEREFORE, in pursuance of Section 12 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby recommends the 21st January, 2014 (Tuesday), as the date on which the President of India may, by notification published in the Gazette of India on the said date, be pleased to call upon the elected members of each of the said Legislative Assemblies of the States, specified in column (1) of the TABLE below, to elect the number of members, specified against the State in column (2) of the said TABLE, to the Council of States, for the purpose of filling the above vacancies, in accordance with the provisions of the said Act and of the Rules and Orders made thereunder :-

यतः सारणी के स्तम्भ (2) में तत्स्थानी प्रविष्टियों में दिखाई गई संख्या के अनुसार नीचे की सारणी के स्तम्भ (1) में विनिर्दिष्ट राज्यों की विधान सभाओं के निर्वाचित सदस्यों द्वारा निर्वाचित राज्यसभा के 55 सदस्यों के स्थान उनकी पदावधि समाप्त होने पर स्तम्भ (3) में तत्स्थानी प्रविष्टियों में वर्णित तारीखों पर उन सदस्यों के सेवा निवृत्त होने पर रिक्त होने हैं ; और

यतः इस प्रकार उत्पन्न हुई रिक्तियों को भरने के उद्देश्य से द्विवार्षिक निर्वाचन कराए जाने हैं।

अतः अब, लोक प्रतिनिधित्व अधिनियम, 1951 (1951 का 43) की धारा 12 के अनुसरण में, भारत निर्वाचन आयोग 21 जनवरी, 2014 (मंगलवार) को उस तारीख के रूप में सिफारिश करता है जिस तारीख को भारत के राष्ट्रपति उक्त तारीख को भारत के राजपत्र में प्रकाशित अधिसूचना द्वारा नीचे की सारणी के स्तम्भ (1) विनिर्दिष्ट राज्य की प्रत्येक विधान सभा के निर्वाचित सदस्यों से यह अपेक्षा करते हैं कि उक्त अधिनियम के उपबन्धों और उसके अधीन बनाए गए नियमों और आदेशों के अनुसार नीचे की सारणी के स्तम्भ (2) में उल्लिखित राज्यों के सामने विनिर्दिष्ट संख्या में उक्त रिक्तियों को भरने के प्रयोजन के लिए सदस्य निर्वाचित कर दें ।
