I am directed to state that "All India Forward Bloc", a recognized State party in the State of West Bengal having reserved symbol 'Lion' in the said State, has requested the Commission for concession under Paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968 for allotment of the said symbol 'Lion' to the candidates being set up by the party at the current Bye-Elections for the Parliamentary / Assembly constituencies of the States mentioned below:-
