I am directed to refer to the subject cited and to state that "Shivsena" a recognized party in the State of Maharashtra, having reserved symbol 'Bow and Arrow', in that state, has requested the Commission for concession under Paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968 for allotment of the said symbol 'Bow and Arrow' to the candidates being set up by the said party at the current Bye-Elections for the Parliamentary / Assembly constituencies of the States mentioned below:-

2. The Commission has decided to extend the concession sought by the party under paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968. Accordingly, the candidates set up by "Shivsena" at the current Bye-Elections to the above mentioned Parliamentary / Assembly constituencies of the States shall be allotted the symbol 'Bow and Arrow'.

The Returning Officers may be informed that the candidates set up by "Shivsena" in the aforesaid Constituencies are eligible for the allotment of the symbol 'Bow and Arrow' under paragraph 10 of the Symbols Order, 1968 subject to strict fulfillment of each of the provisions of paragraph 13 thereof.
